**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF SECURITY SERVICES (A20)**

**Resolution No. 001-2024**  
**Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Security Services – Short of Award under GASS-NEP 2024 with a total Approved Budget for the Contract (ABC) of **Five Million One Hundred Fifteen Thousand Pesos (P5,115,000.00)**;

WHEREAS, an opening of bids was conducted December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bids from Visa Security Services, Sapphire Security Agency and Axzeen Security Agency received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 29, 2023, the BAC determined that the bid submitted by Axzeen Security Agency as the Lowest Calculated Bid and was subjected to post qualification;


WHEREAS, the BAC together with the TWG conducted on January 9, 2024 the post qualification to Axzeen Security Agency having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;


WHEREAS, upon final deliberation conducted by the BAC members on January 12, 2024, it was declared that Axzeen Security Agency had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of Security Services* to Axzeen Security Agency as its bid was considered the Lowest Calculated and Responsive Bid;
