**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 960 HEADS PIGLETS (A22)**

**Resolution No. 005-2024  
Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 960 heads Piglets – Short of Award under Livestock-NEP 2024 with a total Approved Budget for the Contract (ABC) of **Nine Million Six Hundred Thousand Pesos (P9,600,000.00)** grouped into five (5) lots;

<i>Lot 1: 30 heads Agusan del Sur</i>	<i>-Php300,000.00</i>
<i>Lot 2: 390 heads Agusan del Norte</i>	<i>-Php3,900,000.00</i>
<i>Lot 3: 375 heads Surigao del Norte</i>	<i>-Php3,750,000.00</i>
<i>Lot 4: 45 heads Surigao del Sur</i>	<i>-Php450,000.00</i>
<i>Lot 5: 120 heads PDI</i>	<i>-Php1,200,000.00</i>

WHEREAS, an opening of bids was conducted December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, three (3) bids from Julimon International Agri Trading, Juniels Farm and Agrivet Supplies, and Pere-Green Agri Resources received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 27, 2023, the BAC determined that the bid submitted by Julimon International Agri Trading for Lot 1, Lot 2, Lot 3, Lot 4 and Lot 5 as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 17, 2024 the post qualification to Julimon International Agri Trading having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 26, 2024, it was declared that Julimon International Agri Trading had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of *Lot 1: 30 heads Agusan del Sur, Lot 2: 390 heads Agusan del Norte, Lot 3: 375 heads Surigao del Norte, Lot 4: 45 heads Surigao del Sur and Lot 5: 120 heads PDI* to Julimon International Agri Trading as its bid was considered the Lowest Calculated and Responsive Bid;


