BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 2,880 BAGS SWINE FEEDS (A23)

Resolution No. (3) - 4014 Series of 2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 2,880 bags Swine Feeds under Livestock-GAA 2024 with a total Approved Budget for the Contract (ABC) of Five Million Seven Hundred Sixty Thousand Pesos (P5,760,000.00) grouped into ten (10) lots;

Lot 1: 30 bags Hog Starter Agusan del Sur

Lot 2: 390 bags Hog Starter Agusan del Norte

Lot 3: 375 bags Hog Starter Surigao del Norte

Lot 4: 45 bags Hog Starter Surigao del Sur

Lot 5: 120 bags Hog Starter PDI

Lot 6: 60 bags Hog Grower Agusan del Sur

Lot 7: 780 bags Hog Grower Agusan del Norte

Lot 8: 750 bags Hog Grower Surigao del Norte

Lot 9: 90 bags Hog Grower Surigao del Sur

Lot 10: 30 bags Hog Grower PDI


WHEREAS, an opening of bids was conducted on December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bids from Pere-Green Agri Resources and Hiron's General Merchandise received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 27, 2023, the BAC determined that the bid submitted by Pere-Green Agri Resources for Lot 1, Lot 2, Lot 3, Lot 4, Lot 6, Lot 7, Lot 8, Lot 9 and Lot 10 and Hiron's General Merchandise for Lot 5 as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 16 and 18, 2024 the post qualification to Hiron's General Merchandise and Pere-Green Agri Resources, respectively having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon deliberation conducted by the BAC members on February 13, 2024 it was declared that Hiron's General Merchandise and Pere-Green Agri Resources had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of Lot 1: 30 bags Hog Starter Agusan del Sur, Lot 2: 390 bags Hog Starter Agusan del Norte, Lot 3: 375 bags Hog Starter Surigao del Norte, Lot 4: 45 bags Hog Starter Surigao del Sur, Lot 6: 60 bags Hog Grower Agusan del Sur, Lot 7: 780 bags Hog Grower Agusan del Norte, Lot 8: 750 bags Hog Grower Surigao del Norte, Lot 9: 90 bags Hog Growen Supple Her Surgar Copy: 30 bags Hog Grower PDI to Pere-Green Agri Resources while the Procurement of Lot 5: 120 bags Hog Starter PDI to Hiron's General Merchandise as its bid was considered the Lowest Calculated and Responsive Bid;
