

**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF BANANA PLANTING MATERIALS (A38)**  
**Resolution No. 045-2024**  
**Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Banana Planting Materials under SAAD-GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million Two Hundred Forty-Eight Thousand Seven Hundred Eighteen Pesos (P1,248,718.00)** grouped into two (2) lots;

*Lot 1: 9,720 pieces Banana Planting Materials (Lakatan) -Php583,200.00*  
*Lot 2: 13,582 pieces Banana Planting Materials (Cardava) -Php665,518.00*

WHEREAS, an opening of bids was conducted on December 4, 2023, at 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, three (3) bidders bought and submitted their bid, namely, Noybin Nursery & Marketing, St. Padre Pios Garden, and Binahon Agroforestry Farm;

WHEREAS, upon deliberation of the detailed bid evaluation, the BAC determined that the bid submitted by St. Padre Pios Garden for Lot 1 and Binahon Agroforestry Farm for Lot 2 was the Lowest Calculated Bid and subject for post-qualification.

WHEREAS, the BAC together with the TWG conducted on January 31, 2024, the post qualification to St. Padre Pios Garden and Binahon Agroforestry Farm having declared the Lowest Calculated Bid for Lots 1 & 2 respectively, to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on, it was declared that St. Padre Pios Garden and Binahon Agroforestry Farm passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid.

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of 9,720 pieces Banana Planting Materials (Lakatan) to St. Padre Pios Garden for Lot 1 and Procurement of 13,582 pieces Banana Planting Materials (Cardava) to Binahon Agroforestry Farm for Lot 2 as their bid was considered the Lowest Calculated and Responsive Bid;
