BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 2 UNITS HAULING VEHICLE FOR OAP (A15)

**Resolution No. 051-2024
 Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 14, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 2 units Hauling Vehicle for OAP under OA Program-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Six Million Pesos (P6,000,000.00)**;

WHEREAS, an opening of bids was conducted on December 5, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, three (3) bids from Image Motors Davao del Norte Inc., Alpine Motors Corporation and Hino Butuan City, Inc. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 28, 2023, the BAC determined that the bid submitted by Image Motors Davao del Norte Inc. as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 31, 2024 the post qualification to Image Motors Davao del Norte Inc. having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 13, 2024, it was declared that Image Motors Davao del Norte Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of 2 units Hauling Vehicle for OAP* to Image Motors Davao del Norte Inc. as its bid was considered the Lowest Calculated and Responsive Bid;


