**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF  
 VARIOUS COMPONENT FOR THE ESTABLISHMENT OF TWO (2) UNITS FLAT BED  
 DRYER (C9)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Component for the Establishment of Two (2) units Flat Bed Dryer under Corn-GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million Seven Hundred Thirty Thousand Pesos (P1,730,000.00)**;

WHEREAS, an opening of bids was conducted on April 01, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from Suki Trading Corporation, received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the bid submitted by Suki Trading Corporation as the Single Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on May 2, 2024 the post qualification to Suki Trading Corporation having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was declared that Suki Trading Corporation, had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Various Component for the Establishment of Two (2) units Flat Bed Dryer* to Suki Trading Corporation as its bid was considered the Single Calculated and Responsive Bid;


