

CONTRACT AGREEMENT

THIS AGREEMENT made the **22nd day of May 2025** between **Department of Agriculture-Caraga Region** of the Philippines hereinafter called the "Entity" of the one part and **Asian Hybrid Seed Technologies, Inc. of Davao City**, Philippines hereinafter called the "Supplier" of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Hybrid Corn Seeds, Lot 1: 1,551 bags Hybrid Yellow Corn Seeds (NSIC 2018 GMCn 57)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Nine Million One Hundred Forty-Three Thousand One Hundred Forty-Five Pesos Only (P 9,143,145.00)** hereinafter called the "Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Nine Million One Hundred Forty-Three Thousand One Hundred Forty-Five Pesos Only (P 9,143,145.00)** or such other sums as may be ascertained, **Asian Hybrid Seed Technologies, Inc.** agrees to **Procurement of Hybrid Corn Seeds, Lot 1: 1,551 bags Hybrid Yellow Corn Seeds (NSIC 2018 GMCn 57)** in accordance with his/her/its Bid.
4. The **Department of Agriculture-Caraga Region** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

5. The **Asian Hybrid Seed Technologies, Inc.** agrees to indemnify the **Department of Agriculture-Caraga Region** the amount of not less than 10 % of the Contract Price as liquidated damages for failure of **Asian Hybrid Seed Technologies, Inc.** to deliver the above stated goods.
