BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF SECURITY SERVICES (A22)

Resolution No. 001- 1015 Series of 2025

WHEREAS, the Department of AgricultureCaraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Security Services (A22)under GASS-NEP 2025with a total Approved Budget for the Contract (ABC) of Five Million Six Hundred Ninety-Two Thousand Five Hundred Pesos (₱5,692,500.00);

WHEREAS, a pre-bid conference was held virtually through https://tinyurl.com/EPA-Prebid-12052024 last November 21, 2024 as scheduled;

WHEREAS, the opening of bids was conducted on December 17, 2024, at 9:00 AM at the Conference Hall of the Department of Agriculture Regional Field Office XIII in Butuan City, and simultaneously through a virtual platform accessible at https://tinyurl.com/EPA-Opening-12172024. During the proceedings, two (2) bids, submitted by Visa Security Services and Axzeen Security Agency, were received, rated as compliant, and subsequently subjected to a detailed bid evaluation;

WHEREAS, following the deliberation of the detailed bid evaluation on December 29, 2024, the Bids and Awards Committee (BAC) determined that the bid submitted by Axzeen Security Agency, being the Lowest Calculated Bid, was subjected to post-qualification;

WHEREAS, the BAC, together with the TWG conducted post qualification to Axzeen Security Agency on January 9, 2025 in Butuan City;

WHEREAS, upon final deliberation conducted by the BAC members on January 10, 2025, it was declared that Axzeen Security Agency had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of Security Services to Axzeen Security Agency as its bid was considered the Lowest Calculated and Responsive Bid;
