

**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 3,560 BAGS  
ORGANIC FERTILIZER (A5)**

**Resolution No.** 004-2025  
**Series of 2025**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 3,560 Bags Organic Fertilizer under HVCDP-GAA 2025 with a total Approved Budget for the Contract (ABC) of **Two Million Two Hundred Seven-Eight Thousand Four Hundred Pesos (P 2,278,400.00)**;

WHEREAS, an opening of bids was conducted on December 17, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <https://tinyurl.com/EPA-Opening-12172024> as scheduled;

WHEREAS, there were only three (3) bidders who bought and submitted its bid, namely **Goodfarms Trading Corp.**, **Jeel's Masagana Farm Supply, Inc.**, and **Phoenix Larrel Agriventures** received, rated as "Passed"; and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025, the BAC determined that the bid submitted by **Phoenix Larrel Agriventures** as the Lowest Calculated Bid is non-compliant with the Technical Specifications for Organic Fertilizer, as they offered an Organic Plant Supplement product which is a valid ground for the disqualification. Hence, **Goodfarms Trading Corp.** was evaluated and found to be eligible and declared as the Second Lowest Responsive Bidder is subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 22, 2025 to **Goodfarms Trading Corp.**, having declared the Second Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that **Goodfarms Trading Corp.** had passed the post qualification requirements and was considered the Second Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of 3,560 Bags Organic Fertilizer* to **Goodfarms Trading Corp.** as its bid was considered the Second Lowest Calculated and Responsive Bid;
