BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 2,976 HEADS CHICKEN (READY-TO-LAY PULLETS) WITH PRE-FABRICATED CAGE (A18)

Resolution No. $\frac{99-815}{\text{Series of 2025}}$

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 2,976 Heads Chicken (Ready-To-Lay Pullets) with Pre-Fabricated Cage under SAAD-GAA 2025 with a total Approved Budget for the Contract (ABC) of Three Million Five Hundred Seventy-One Thousand Two Hundred Pesos (P3,571,200.00);

WHEREAS, an opening of bids was conducted on December 17, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through https://tinyurl.com/EPA-Prebid-12172024 as scheduled:

WHEREAS, there were only two (2) bidders who bought and submitted its bid, namely Abastillas Livestock, and Julimon Int'l Agri Trading Corp. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025, the BAC determined that the bid submitted by Abastillas Livestock as the Lowest Calculated Bid is subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 20, 2025 to Abastillas Livestock, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that Abastillas Livestock did not submit their AWA Registraion, hence, "failed. Therefore, Julimon International Corp. Inc. was evaluated as the Second Lowest Calculated bid and is subject for post Qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 31, 2025 to Julimon International Corp. Inc., having declared as the Second Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 3, 2025, it was declared that Julimon International Corp. Inc. had passed the post qualification requirements and was considered the Second Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of 2,976 heads Chicken (Ready-to-Lay Pullets) with Prefabricated Cage to Julimon International Corp. Inc. as its bid was considered the Second Lowest Calculated and Responsive Bid;
