BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF ASSORTED **LOWLAND VEGETABLE SEEDS (A23)**

Resolution No. 008- 1025 Series of 2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 3,162 Bags Feeds (Layer) - Short of Award under NUPAP-NEP 2025 with a total Approved Budget for the Contract (ABC) of Two Million Four Hundred Forty-Nine Thousand Eight Hundred Ninety-Five Pesos (P 2,449,895.00);

WHEREAS, an opening of bids was conducted on December 17, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through https://tinyurl.com/EPA-Opening-12172024 as scheduled;

WHEREAS, there were only four (4) bidders who bought and submitted its bid, namely Allied Botanical Corp., Jeel's Masagana Farm Supply, Inc., Ramgo Intl Corp., and Pilipinas Kaneko Seeds Corp. received, rated as "Passed" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025, the BAC determined that the bid submitted by Pilipinas Kaneko Seeds Corp. as the Lowest Calculated Bid and is subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 22, 2025 to Pilipinas Kaneko Seeds Corp., having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that Pilipinas Kaneko Seeds Corp. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of Assorted Lowland Vegetable Seeds to Pilipinas Kaneko Seeds Corp. as its bid was considered the Lowest Calculated and Responsive Bid;
