## BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF GARDEN MATERIALS AND TOOLS (A24)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Garden Materials and Tools - Short of Award under NUPAP-NEP 2025 with a total Approved Budget for the Contract (ABC) of One Million Nine Hundred Five Thousand Pesos (P 1,905,000.00):

WHEREAS, an opening of bids was conducted on December 17, 2024 at the 3rd Floor Conference Hall. Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through https://tinyurl.com/EPA-Opening-12172024 as scheduled:

WHEREAS, there were only three (3) bidders who bought and submitted its bid, namely, CE Future Builder Corporation, DJ & J Trading & General Merchandise, and Jeel's Masagana Farm Supply, Inc. received, rated as "Passed" and subsequently subjected to a detailed bid evaluation:

WHEREAS, upon deliberation of the detailed bid evaluation on January 14, 2025, the BAC determined that the bid submitted by DJ & J Trading & General Merchandise as the Second Lowest Calculated Bid and is subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 24, 2025 to DJ & J Trading & General Merchandise, having declared the Second Lowest Calculated Bid to determine its capability to supply the contract if awarded:

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that DJ & J Trading & General Merchandise had passed the post qualification requirements and was considered the Second Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of Garden Materials and Tools to DJ & J Trading & General Merchandise as its bid was considered the Second Lowest Calculated and Responsive Bid;
