## BAC RESOLUTION RECOMMENDING AWARD FOR THE FOR BIDS FOR THE PROCUREMENT OF **GROWING BOX AND PLASTIC CRATES (A25)**

Resolution No. 610-1025 Series of 2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Garden Materials under NUPAP-GAA 2025 with a total Approved Budge for the Contract (ABC) of One Million Seven Hundred Twenty-Five Thousand Pesos (P 1,725,000.00) grouped into Two (2) Lots;

Lot 2: Plastic Crates

WHEREAS, an opening of bids was conducted on December 17, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <a href="https://tinyurl.com/EPA-Opening-12172024">https://tinyurl.com/EPA-Opening-12172024</a> as scheduled;

WHEREAS, there were only three (3) bidders who bought and submitted its bid, namely, CE Future Builder Corporation, Sentinel Plastic Manufacturing Corporation, and Jeel's Masagana Farm Supply, Inc. received, rated as "Passed" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 14, 2025, the BAC determined that the bid submitted by Sentinel Plastic Manufacturing Corporation as the Second Lowest Calculated Bid is subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 23, 2025 to Sentinel Plastic Manufacturing Corporation, having declared the Second Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that Sentinel Plastic Manufacturing Corporation had passed the post qualification requirements and was considered the Eligible Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of Growing Box and Plastic Crates Lot 1 - Hydroponics Growing Box and Lot 2 - Plastic Creates to Sentinel Plastic Manufacturing **Corporation** as its bid was considered the Eligible Calculated and Responsive Bid;
