BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF THREE (3) UNITS BIOMASS SHREDDER (A26)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 26, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Three (3) units Biomass Shredder under NUPAP-GAA 2025 with a total Approved Budget for the Contract (ABC) of Nine Hundred Thousand Pesos (P 900,000.00);

WHEREAS, an opening of bids was conducted on December 16, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through https://tinyurl.com/EPA-Prebid-12162024 as scheduled;

WHEREAS, there was only one (1) bidder who bought and submitted its bid, namely **Suki Trading Corp**. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025, the BAC determined that the bid submitted by **Suki Trading Corp.** as the Single Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 31, 2025 to **Suki Trading Corp.**, having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 3, 2025, it was declared that **Suki Trading Corp.** had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Three (3) units Biomass Shredder* to **Suki Trading Corp.** as its bid was considered the Single Calculated and Responsive Bid;
