

BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF GREENHOUSE (A27)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for The Construction of Greenhouse under NUPAP-GAA with a total Approved Budget for the Contract (ABC) of **Two Million Five Hundred Thousand Pesos (P 2,500,000.00)** grouped into two (2) lots;

Particulars	ABC (Php)
Lot 1: for Agusan del Norte	P 1,500,000.00
Lot 2: for Agusan del Sur	P 1,000,000.00

WHEREAS, an opening of bids was conducted on December 17, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <https://tinyurl.com/EPA-Opening-12172024> as scheduled;

WHEREAS, there were only three (3) bidders who bought and submitted its bid, namely **Uni Vista Corp.** and **AA Construction & Supply** for Lots 1 and 2, and **CE Future Builders Corp.** for Lot 2 only which were received, rated as "Passed" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025, the BAC determined that the bid submitted by **Uni Vista Corporation** for Lot 1 as the Second Lowest Calculated Bid and Lot 2 as the Third Lowest Calculated Bid is subject for post qualification;


WHEREAS, the BAC together with the TWG conducted the post qualification on January 21, 2025 to **Uni Vista Corporation** for Lot 1 as the Second Lowest Calculated Bid and Lot 2 as the Third Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that **Uni Vista Corporation** had passed the post qualification requirements and was considered the Next Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Labor and Materials for The Construction of Greenhouse Lots 1 and 2 - Agusan Del Norte* to **Uni Vista Corporation** as its bid was considered the Next Lowest Calculated and Responsive Bid;


