



BAC RESOLUTION RECOMMENDING AWARD FOR THE LABOR AND MATERIALS FOR THE CONSTRUCTION OF BANANA CONSOLIDATION CENTER (A28-1)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Labor and Materials for the Construction of Banana Consolidation Center under HVCDP-GAA 2025 with a total Approved Budget for the Contract (ABC) of **Two Million Pesos (P 2,000,000.00)**;

WHEREAS, an opening of bids was conducted on December 17, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <https://tinyurl.com/EPA-Prebid-12172024> as scheduled;

WHEREAS, there were only two (2) bidders who bought and submitted its bid, namely **RMB Devt Corp.** and **AA Construction & Supply** received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025, the BAC determined that the bid submitted by **AA Construction & Supply** as the Lowest Calculated Bid is non-compliant due to being found to have no declaration of DA Implemented Projects. Hence, **RMB Development Corp.** was evaluated and found to be eligible and declared as the Second Lowest Responsive Bidder is subject for post qualification;


WHEREAS, the BAC together with the TWG conducted the post qualification on January 30, 2025 to **RMB Development Corp.**, having declared the Second Lowest Calculated Bid to determine its capability to supply the contract if awarded;


WHEREAS, upon final deliberation conducted by the BAC members on February 3, 2025, it was declared that **RMB Development Corp.** had passed the post qualification requirements and was considered the Second Lowest Calculated and Responsive Bid;


NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Labor and Materials for the Construction of Banana Consolidation Center* to **RMB Development Corp.** as its bid was considered the Second Lowest Calculated and Responsive Bid;
