



BAC RESOLUTION RECOMMENDING AWARD FOR PROCUREMENT OF AGRICULTURAL CHEMICALS (A30)

Resolution No. 014-2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Agricultural Chemicals under CORN-GAA 2025 with a total Approved Budget for the Contract (ABC) of **Nine Hundred Eighty-Five Thousand Two Hundred Fifty Pesos (P 985,250.00)** grouped into two (2) lots;

Lot 1: 1,050 Sachets Bactericide	P 299,250.00
Lot 2: 20 Bottles Rodenticide & 600-gal Herbicide	P 686,000.00

WHEREAS, an opening of bids was conducted on December 17, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <https://tinyurl.com/EPA-Opening-12162024> as scheduled;

WHEREAS, there were only three (3) bidders who bought and submitted its bid, namely, **Caraga Gen. Mdse. Interprises Inc.** which was rated as "Failed" and **Verca Agro Chem, Inc.** for Lot 1, and **Mars Agri Ventures and Commodities, Inc.** for Lot 2 received, rated as "Passed" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 14, 2025, the BAC determined that the bid submitted by **Verca Agro Chem, Inc.** as the Single Calculated Bid for Lot 1 and **Mars Agri Ventures and Commodities, Inc.** for Lot 2, and are subject for post qualification;


WHEREAS, the BAC together with the TWG conducted the post qualification on January 22, 2025 to **Verca Agro Chem, Inc.** for Lot 1 and **Mars Agri Ventures and Commodities, Inc.** for Lot 2 both, having declared as the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that **Verca Agro Chem, Inc.** for Lot 1 had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Agricultural Chemicals Lot 1 – 1,050 Sachets Bactericide* to **Verca Agro Chem, Inc.** and *Lot 2 – 20 Bottles Rodenticide & 600-gal Herbicide* to **Mars Agri Ventures and Commodities, Inc.** as both bid were considered as the Single Calculated and Responsive Bid;




