## BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS INORGANIC FERTILIZER (A32)

Resolution No. Off 1025 Series of 2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Inorganic Fertilizer under AMIA-GAA 2025 with a total Approved Budget for the Contract (ABC) of Four Hundred Eighty-Eight Thousand Four Hundred Forty Pesos (P 488,440.00);

WHEREAS, an opening of bids was conducted on December 17, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <a href="https://tinyurl.com/EPA-Opening-12172024">https://tinyurl.com/EPA-Opening-12172024</a> as scheduled;

WHEREAS, there was only one (1) bidder who bought and submitted its bid, namely, Mars Agri Ventures and Commodities, Inc. received, rated as "Passed" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 14, 2025, the BAC determined that the bid submitted by **Mars Agri Ventures and Commodities, Inc.** as the Single Calculated Bid and is subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 21, 2025 to **Mars Agri Ventures and Commodities, Inc.**, having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that Mars Agri Ventures and Commodities, Inc. had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Various Inorganic Fertilizer* to **Mars Agri Ventures and Commodities** as its bid was considered the Single Calculated and Responsive Bid;
