BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF POULTRY ANIMALS (A34)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 28, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Poultry Animals under AMIA–GAA 2025 with a total Approved Budget for the Contract (ABC) of **Eight Hundred Seventy-Two Thousand Four Hundred Pesos (P 872,400.00)** grouped into two (2) lots;

WHEREAS, an opening of bids was conducted on December 18, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through https://tinyurl.com/EPA-Prebid-12182024;

WHEREAS, there were only three (3) bidders who bought and submitted its bid, namely **Julimon Int'l Agri Trading Corp**. and **CJP Enterprises** received for Lots 1 and 2, and **Abastillas Livestock** for Lot 1 only were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 14, 2025, the BAC determined that the bid submitted by **Julimon Int'l Agri Trading Corp.** as the Second Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 23, 2025 to **Julimon Int'l Agri Trading Corp.**, having declared the Second Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 3, 2025, it was declared that **Julimon Int'l Agri Trading Corp.** had passed the post qualification requirements and was considered the Second Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Poultry Animals Lot* 1-480 *Heads Ready and Lot* 2-247 *Heads Mallard Ducks (Itik Pinas)* to **Julimon Int'l Agri Trading Corp.** as its bid was considered the Second Lowest Calculated and Responsive Bid;
