

**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS SEEDS (A36)**

**Resolution No.** 019- 2025  
**Series of 2025**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 28, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Seeds under OAP-GAA 2025 with a total Approved Budget for the Contract (ABC) of **Three Million Eight Hundred Ninety-One Thousand Seven Hundred Eleven Pesos (P 3,891,711.00)** grouped into Three (3) Lots;

WHEREAS, an opening of bids was conducted on December 18, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <https://tinyurl.com/EPA-Opening-12172024> as scheduled;

WHEREAS, there were only four (4) bidders who bought and submitted its bid, namely, **Marao Integrated Farm** for Lot 2, **Allied Botanical Corp., Ramgo Intl. Corp., and Pilipinas Kaneko Seeds Corp.** for Lot 3 received, rated as "Passed" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 14, 2025, the BAC determined that the bid submitted by **Marao Integrated Farm** as the Single Calculated Bid for Lot 2 and **Pilipinas Kaneko Seeds Corp.** as the Lowest Calculated Bid for Lot 3, and are subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 22, 2025 to **Marao Integrated Farm**, having declared the Single Calculated Bid for Lot 2 and **Pilipinas Kaneko Seeds Corp.**, having declared the Lowest Calculated Bid for Lot 3 to determine their capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that **Marao Integrated Farm** for Lot 2 and **Pilipinas Kaneko Seeds Corp.** for Lot 3 had passed the post qualification requirements and was considered the Eligible and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Various Seeds Lot 2 - 745 Bags OPV Corn Seeds (White)* to **Marao Integrated Farm** and *Lot 3 - Assorted Vegetable Seeds* to **Pilipinas Kaneko Seeds Corp.** as its bid were considered Eligible and Responsive Bid;
