

**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS VEGETABLE SEEDS (LOWLAND AND UPLAND) (A39)**

**Resolution No. 020-2025  
Series of 2025**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 28, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Vegetable Seeds (Lowland and Upland) under HVCDP-GAA 2025 with a total Approved Budget for the Contract (ABC) of **Thirteen Million Three Hundred Ninety Thousand Three Hundred Forty-One Pesos (P 13,390,341.00)** grouped into two (2) Lots;

WHEREAS, an opening of bids was conducted on December 18, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <https://tinyurl.com/EPA-Opening-12182024> as scheduled;

WHEREAS, there were only five (5) bidders who bought and submitted its bid, namely, **Thaiphil Advance Agritech Corp. (TPAAC)**, **Jeel's Masagana Farm Supply, Inc.**, **Ramgo Intl. Corp.** and **Allied Botanical Corp.** for Lots 1 and 2 received, rated as "Passed" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 14, 2025, the BAC determined that the bid submitted by **Ramgo Intl. Corp.** for Lots 1 and 2 as the Lowest Calculated Bid and is subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 23, 2025 to **Ramgo Intl. Corp.** for Lots 1 and 2, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that **Ramgo Intl. Corp.** had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid for Lots 1 and 2;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Various Vegetable Seeds Lot 1 – Assorted Vegetable Seeds and Lot 2 – Assorted Vegetable Seeds (Budder Stocks)* to **Ramgo Intl. Corp.** as its bid was considered the Lowest Calculated and Responsive Bid for Lots 1 and 2;
