

BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF HYBRID RICE SEEDS (A41)

**Resolution No. 021-2025
Series of 2025**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 28, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Hybrid Rice Seeds under RICE-GAA 2025 with a total Approved Budget for the Contract (ABC) of **Four Million Seven Hundred Sixty-Three Thousand Two Hundred Pesos (P 4,763,200.00)** grouped into five (5) Lots;

WHEREAS, an opening of bids was conducted on December 18, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <https://tinyurl.com/EPA-Prebid-12182024> as scheduled;

WHEREAS, there were only four (4) bidders who bought and submitted its bid, namely, **SL Agritech Corp. for Lot 2, Leads Agriventure Corp. for Lots 1 and 5, Jedeco Trading Corp. for Lot 4, and Davao Oriental Seed Producers Coop. (DOSEPCO) for Lot 3** received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 17, 2025, the BAC determined that the bid submitted by **SL Agritech Corp. for Lot 2, Leads Agriventure Corp. for Lots 1 and 5, Jedeco Trading Corp. for Lot 4, and Davao Oriental Seed Producers Coop. (DOSEPCO) for Lot 3** were all the Single Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 31, 2025 to **SL Agritech Corp. for Lot 2, Leads Agriventure Corp. for Lots 1 and 5, Jedeco Trading Corp. for Lot 4, and Davao Oriental Seed Producers Coop. (DOSEPCO) for Lot 3**, having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 3, 2025, it was declared that **Leads Agriventure Corp. for Lots 1 and 5** had failed due to expired Philgeps while **SL Agritech Corp. for Lot 2, Davao Oriental Seed Producers Coop. (DOSEPCO) for Lot 3, and Jedeco Trading Corp. for Lot 4** had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Hybrid Rice Seeds Lot 2 – Hybrid Rice Seeds (M81) to SL Agritech Corp., Lot 3 – Hybrid Rice Seeds (Public -M20) Davao Oriental Seed Producers Coop. (DOSEPCO), and Lot 4 – Hybrid Rice Seeds (M46) to Jedeco Trading Corp.* as their bid were considered the Single Calculated and Responsive Bid;


