BAC RESOLUTION RECOMMENDING AWARD FOR THE LABOR AND MATERIALS FOR THE CONSTRUCTION OF FREE-RANGE CHICKEN HOUSE (A44)

Resolution No. 011-1015 Series of 2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 30, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Labor and Materials for the Construction of Free-Range Chicken House under LIVESTOCK-GAA 2025 with a total Approved Budget for the Contract (ABC) of **One Million Five Hundred Thousand Pesos (P 1,500,000.00)**;

WHEREAS, an opening of bids was conducted on December 20, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through https://tinyurl.com/EPA-Prebid-12202024 as scheduled;

WHEREAS, there were only three (3) bidders who bought and submitted its bid, namely AA Construction and Supply, FHD Construction & Supply, and Resaga Construction received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025, the BAC determined that the bid submitted by **AA Construction and Supply** as the Lowest Calculated Bid was found out that there were some inconsistencies in the quantity that they offered for item 1014 (1b2) prepainted metal sheet Ga.26 long span and in the unit measure for item B5 Project Billboard/Signboard. Hence, **FHD Construction & Supply** as the Third Lowest Calculated Bid is subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 31, 2025 to **FHD Construction and Supply**, having declared the Third Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 3, 2025, it was declared that **FHD Construction and Supply** had passed the post qualification requirements and was considered the Third Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Labor and Materials for the Construction of Free-Range Chicken House* to **FHD Construction and Supply** as its bid was considered the Third Lowest Calculated and Responsive Bid;
