



**BAC RESOLUTION RECOMMENDING AWARD FOR THE LABOR & MATERIALS FOR THE ESTABLISHMENT OF BIOSECURED SWINE HOUSING FACILITY (A46)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 30, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Labor & Materials for the Establishment of Biosecured Swine Housing Facility under LIVESTOCK-GAA 2025 with a total Approved Budget for the Contract (ABC) of **Six Million Pesos (P 6,000,000.00)**;

WHEREAS, an opening of bids was conducted on December 20, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <https://tinyurl.com/EPA-Prebid-12202024> as scheduled;

WHEREAS, there were only two (2) bidders who bought and submitted its bid, namely **RMB Development Corporation** and Zeart Construction Supply Co. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025, the BAC determined that the bid submitted by **RMB Development Corporation** as the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 30, 2025 to **RMB Development Corporation**, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 3, 2025, it was declared that **RMB Development Corporation** had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Labor & Materials for the Establishment of Biosecured Swine Housing Facility* to **RMB Development Corporation** as its bid was considered the Lowest Calculated and Responsive Bid;




