

BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS INORGANIC FERTILIZER (A53)

**Resolution No. 014-2025
Series of 2025**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 30, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Inorganic Fertilizer under CORN-GAA 2025 with a total Approved Budget for the Contract (ABC) of **Twenty-Six Million Four Hundred Forty-Four Thousand Pesos (P 26,444,000.00)** grouped into Five (5) lots;

WHEREAS, an opening of bids was conducted on December 20, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <https://tinyurl.com/EPA-Opening-12202024> as scheduled;

WHEREAS, there were only two (2) bidders who bought and submitted its bid, namely, **Mars Agriventures and Commodities, Inc.**, and **Goodfarms Trading Corp.** received, rated as "Passed" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 14, 2025, the BAC determined that the bid submitted by **Mars Agriventures and Commodities, Inc.** for Lots 1, 2, and 5 as the Lowest Calculated Bid, and **Goodfarms Trading Corp.** for Lot 3 as the Single Calculated Bid and is subject for post qualification; no bid for Lot 4;


WHEREAS, the BAC together with the TWG conducted the post qualification on January 21, 2025 to **Mars Agriventures and Commodities, Inc.** for Lots 1, 2, and 5 as the Lowest Calculated Bid, and January 22, 2025 to **Goodfarms Trading Corp.** for Lot 3 as the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that **Mars Agriventures and Commodities, Inc.** for Lots 1, 2, and 5 had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid, and **Goodfarms Trading Corp.** for Lot 3 had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Various Inorganic Fertilizer* to **Goodfarms Trading Corp.** for Lot 3 as the Single Calculated Bid, and **Mars Agriventures and Commodities, Inc.** for Lots 1, 2, and 5 as its bid was considered the Lowest Calculated and Responsive Bid;


