**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS
INORGANIC FERTILIZER (A20)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Inorganic Fertilizer under HVCDP-GAA 2025 with a total Approved Budget for the Contract (ABC) of **One Million Five Hundred Forty-Two Thousand One Hundred Pesos (P 1,542,100.00)**;

WHEREAS, an opening of bids was conducted on December 17, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <https://tinyurl.com/EPA-Opening-12172024> as scheduled;

WHEREAS, there were only two (2) bidders who bought and submitted its bid, namely **Mars Agri Ventures & Commodities, Inc.** and **Modern Time Enterprises Inc.** received, rated as "Passed" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025, the BAC determined that the bid submitted by Mars Agri Ventures & Commodities, Inc. as the Lowest Calculated Bid and is subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 21, 2025 to **Mars Agri Ventures & Commodities, Inc.**, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that **Mars Agri Ventures & Commodities, Inc.** had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Various Inorganic Fertilizer* to **Mars Agri Ventures & Commodities** as its bid was considered the Lowest Calculated and Responsive Bid;
