

BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS PLANTING MATERIALS (A17)

**Resolution No. 031-2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Planting Materials under SAAD-GAA 2025 with a total Approved Budget for the Contract (ABC) of **One Million Two Hundred Twenty-Five Thousand Five Hundred Pesos (P 1,225,500.00)** grouped into three (3) lots;

Lot 2: 6,500Pcs Banana Planting Materials	P 347,750.00
Lot 3: 17,500Pcs Pineapple Planting Materials	P 595,000.00

WHEREAS, an opening of bids was conducted on December 17, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <https://tinyurl.com/EPA-Opening-12172024> as scheduled;

WHEREAS, there was only one (1) bidder who bought and submitted its bid, namely **Ernie Agroforest Nursery** for Lot 1 received, rated as "Passed" and subsequently subjected to a detailed bid evaluation; no bid for Lots 2 and 3;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025, the BAC determined that the bid submitted by **Ernie Agroforest Nursery** for Lot 1 as the Single Calculated Bid and is subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 17, 2025 to **Ernie Agroforest Nursery**, having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that **Ernie Agroforest Nursery** had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid for Lot 1;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Various Planting Materials* to **Ernie Agroforest Nursery** as its bid was considered the Single Calculated and Responsive Bid for Lot 1;


