BAC RESOLUTION RECOMMENDING AWARD FOR THE LABOR & MATERIALS FOR THE CONSTRUCTION OF CHICKEN LAYING HOUSE (A47)

Resolution No. <u>534 - 1015</u> Series of 2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 30, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Labor & Materials for the Construction of Chicken Laying House under LIVESTOCK-GAA 2025 with a total Approved Budget for the Contract (ABC) of Nineteen Million Eight Hundred Thousand Pesos (P 19,800,000.00) grouped into five (5) Lots;

WHEREAS, an opening of bids was conducted on December 20, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through https://tinyurl.com/EPA-Prebid-12202024 as scheduled;

WHEREAS, there were only four (4) bidders who bought and submitted its bid, namely Zeart Construction Supply, Co. for Lots 1 to 5, Resaga Construction for Lot 3, Bamboe Construction for Lot 4, and AJP Builders & Supplies for Lot 4, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025, the BAC determined that the bid submitted by **Bamboe Construction** for Lot 4 as the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on January 17, 2025 to Bamboe Construction, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded. However, the bidder submitted a waiver to withdraw their bid;

WHEREAS, upon final deliberation conducted by the BAC members on January 27, 2025, it was declared that **Bamboe Construction** has waived its bid, therefore, **AJP Builders & Supplies** as the Second Lowest Bid is subject for post qualification;

WHEREAS, upon final deliberation conducted by the BAC members on February 3, 2025, it was declared that AJP Builders and Supplies had passed the post qualification requirements and was considered the second lowest calculated and responsive bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Labor & Materials for the Construction of Chicken Laying House Lot 4 – Province of Surigao del Norte to AJP Builders & Supplies as its bid was considered the Second Lowest Calculated and Responsive Bid;
