## BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS VEGETABLE SEEDS (A33)

Resolution No. 035 - 1015 Series of 2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Vegetable Seeds under AMIA-GAA 2025 with a total Approved Budget for the Contract (ABC) of Seven Hundred Forty-Eight Thousand One Hundred Sixty Pesos (P 748,160.00);

WHEREAS, an opening of bids was conducted on December 17, 2024 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated virtually through <a href="https://tinyurl.com/EPA-Opening-12172024">https://tinyurl.com/EPA-Opening-12172024</a>;

WHEREAS, there were only four (4) bidders who bought and submitted its bid, namely, Pilipinas Kaneko Seeds Corp., Allied Botanical Corporation, Jeels Masagana Farm Supply Inc., and Ramgo International;

WHEREAS, upon deliberation of the detailed bid evaluation on January 14, 2025, the BAC determined that the bid submitted by **Pilipinas Kaneko Seeds Corp.** as the Lowest Calculated Bid and is subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification to **Pilipinas Kaneko Seeds Corp**. on January 22, 2025, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on April 7, 2025, it was declared that **Pilipinas Kaneko Seeds Corp.** had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Various Vegetable Seeds* to **Pilipinas Kaneko Seeds Corp.** as its bid was considered the Lowest Calculated and Responsive Bid;
