

**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF THREE (3)
UNITS FARM TRACTOR (A4)**
Resolution No. 036-2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on November 26, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Procurement of Three (3) units Farm Tractor** under **HVCD Program-2025 GAA** with a total Approved Budget for the Contract (ABC) of **Four Million Nine Hundred Eighty Thousand Pesos (P 4,980,000.00)**.

WHEREAS, a pre-bid conference was conducted as scheduled on December 4, 2024 at the 3rd Floor Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through <https://tinyurl.com/EPA-Prebid-12042024>.

WHEREAS, the opening of bids was conducted as scheduled on December 16, 2024 at the 3rd Floor Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through <https://tinyurl.com/EPA-Opening-12162024>.

WHEREAS, only one (1) bidder purchased bid documents and successfully submitted the bid, namely, **Ford Tractor Phils Inc.**

WHEREAS, upon opening of bid documents, the BAC members examined the submitted technical component of the bid to verify the presence or absence of the required documents. It was determined that the bidder complied with the eligibility and technical components and was rated as "Passed"; and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025 to determine the lowest calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents, the BAC determined that the bid submitted by **Ford Tractor Phils Inc.** as the Single Calculated Bid and is subject for post qualification;

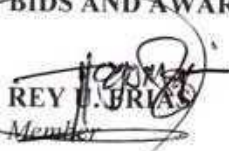
WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **Ford Tractor Phils Inc.** met all legal, technical, and financial requirements and deemed Responsive Bidder;

WHEREAS, the BAC, after careful deliberation, verification of submitted documents, and with the authority to purchase Motor Vehicle/s released by the Department of Budget and Management (DBM), on April 7, 2025, **RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract amounting to **P4,950,000.00** to **Ford Tractor Phils Inc.**;

NOW, THEREFORE, the BAC recommends the award of the contract for the **Procurement of Three (3) units Farm Tractor** under **HVCD Program** to **Ford Tractor Phils Inc.**, subject to the approval of the Head of the Procuring Entity (HOPE) and compliance with post-award requirements as their bid was considered the Single Calculated and Responsive Bid;
