

**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF
SEVEN (7) UNITS OF CORN COMBINE HARVESTER (A10)**
Resolution No. 038-2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on November 26, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Procurement of Seven (7) units Corn Combine Harvester under Corn Program-2025 GAA** with a total Approved Budget for the Contract (ABC) of **Twenty-One Million Pesos (P 21,000,000.00)**.

WHEREAS, a pre-bid conference was conducted as scheduled on December 4, 2024 at the 3rd Floor Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through <https://tinyurl.com/EPA-Prebid-12042024>.

WHEREAS, the opening of bids was conducted as scheduled on December 16, 2024 at the 3rd Floor Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through <https://tinyurl.com/EPA-Opening-12162024>.

WHEREAS, there were only two (2) bidders who bought and submitted its bid, namely **Fortune Tract Agro-Sales, Inc.** and **Agricomponent Corp.**;

WHEREAS, upon the opening of the bids, the BAC members examined the submitted technical component of the bid to verify the presence or absence of the required documents and were rated as follows:

WHEREAS, the financial component of the above two (2) bids rated as “Passed” were opened and read as indicated on the abstract of bids which will be subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 13, 2025 to determine the lowest calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents, the BAC determined that the bid submitted by **Agricomponent Corp.** as the Lowest Calculated Bid and is subject for post qualification;


WHEREAS, after conducting the Post-Qualification Evaluation on January 24, 2025, the BAC determined that **Agricomponent Corp** met all legal, technical, and financial requirements and deemed Responsive Bidder;

WHEREAS, the BAC, after careful deliberation, verification of submitted documents, and with the authority to purchase Motor Vehicle/s released by the Department of Budget and Management (DBM), on April 7, 2025, **RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract amounting to **P20,965,000.00** to **Agricomponent Corp.**;

NOW, THEREFORE, the BAC recommends the award of the contract for the **Procurement of Seven (7) units Corn Combine Harvester** under **Corn Program** to **Agricomponent Corp.**, subject to the approval of the Head of the Procuring Entity (HOPE) and compliance with post-award requirements as their bid was considered the Lowest Calculated and Responsive Bid;
