# BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF FOUR (4) UNITS HAULING VEHICLE (A50)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on November 26, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for Procurement of Four (4) units Hauling Vehicle under Rice Program-2025 GAA with a total Approved Budget for the Contract (ABC) of Twelve Million Pesos (P 12,000,000.00).

WHEREAS, a pre-bid conference was conducted as scheduled on December 9, 2024 at the 3rd Floor Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through https://tinyurl.com/EPA-Prebid-12092024.

WHEREAS, the opening of bids was conducted as scheduled on December 20, 2024 at the 3rd Floor Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through https://tinyurl.com/EPA-Opening-12202024.

WHEREAS, there were only four (4) bidders who bought and submitted its bid, namely, Alpine Motors Corporation, Autokid Subic Trading Corporation, Golden Dynasty Motors (GDM) Inc, and Superior Motor Corporation;

WHEREAS, upon the opening of the bids, the BAC members examined the submitted technical component of the bid to verify the presence or absence of the required documents and were rated as follows:

WHEREAS, the financial component of the above four (4) bids rated as "Passed" were opened and read as indicated on the abstract of bids which will be subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 14, 2025 to determine the lowest calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents, the BAC determined that the bid submitted by Autokid Subic Trading Corporation as the Lowest Calculated Bid and is subject for post qualification;
