

**BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE
PROCUREMENT OF THREE (3) UNITS FARM TRACTOR (B5)**

**Resolution No. 043- 2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Procurement Of Three (3) Units Farm Tractor (B5)** under **Corn Program** with a total Approved Budget for the Contract (ABC) of **Nine Million Pesos (₱9,000,000.00)**;

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through <https://bit.ly/Prebid-CodeB-03172025>;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, only (1) bidder purchased bid documents and successfully submitted the bid, namely, **Ford Tractor Philippines**;

WHEREAS, upon opening of bid documents, the BAC members conducted an examination of the submitted technical and financial components to verify the completeness and compliance of the required documents. The bid was evaluated and rated as "PASSED";

WHEREAS, based on the preliminary deliberation, the bidder has been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 10, 2025 to determine the responsive bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, the BAC declared **Ford Tractor Philippines** as responsive and subject to post-qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **Ford Tractor Philippines** met all legal, technical, and financial requirements and deemed as the Lone and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, **RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract with a total amount of **₱8,994,000.00** to **Ford Tractor Philippines**;
