WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for Procurement Of Various Equipment For Soybean (B8) under Corn Program—2025 GAA with a total Approved Budget for the Contract (ABC) of Two Million Six Hundred Sixty-Four Thousand Pesos (\$\mathbb{P}2,664,000.00) with procurement by lot as follows:

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through https://bit.ly/Prebid-CodeB-03172025;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, only one (1) bidder purchased bid documents and successfully submitted bids for lots 1,2, and 3, namely, **Davao Techno Craft**;

WHEREAS, upon opening of bid documents, the BAC members conducted an examination of the submitted technical and financial components to verify the completeness and compliance of the required documents. The bids were evaluated and rated as "PASSED" for lots 1, 2, and 3;

WHEREAS, based on the preliminary deliberation, Davao Techno Craft has been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 10, 2025 to determine the single bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, Davao Techno Craft is the single bidder for Lots 1, 2, and 3 of B8 and subject to post-qualification process to verify the eligibility, legal, technical, and financial requirements of the lone and lowest calculated bids;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **Davao Techno Craft** met all legal, technical, and financial requirements and deemed as the Single and Responsive Bidder for lots 1, 2, and 3 of B8;
