WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net), on March 8, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Procurement of Hybrid Corn Seeds Lot 2 – 1,035 bags Hybrid Yellow Corn Seeds (NSIC 2023 GMCN 89) (B30 Lot 2)** under **Corn Program–2025 GAA** with a total Approved Budget for the Contract (ABC) of **Six Million Two Hundred Ten Thousand Pesos (P6,210,000.00);**

WHEREAS, a pre-bid conference was conducted as scheduled on March 18, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through <https://tinyurl.com/Prebid-CodeB-03182025>;

WHEREAS, the opening of bids was conducted as scheduled on April 2, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, only one bidder purchased bid documents and successfully submitted the bids, namely, **St. Joseph Marketing Corporation;**

WHEREAS, upon opening of bid documents, the BAC members conducted an examination of the submitted technical and financial components to verify the completeness and compliance of the required documents;

WHEREAS, based on the preliminary deliberation, **St. Joseph Marketing Corporation** has been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 10, 2025 to determine the single calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, **St. Joseph Marketing Corporation** submitted the single bid and hereby resolves to subject to post-qualification process to verify the eligibility, legal, technical, and financial requirements of the lone calculated bids;

WHEREAS, after conducting the Post-Qualification Evaluation on April 15, 2025, the BAC determined that **St. Joseph Marketing Corporation** met all legal, technical, and financial requirements and are deemed as the Single Calculated and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, **RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract with a total amount of **P6,210,000.00** to **St. Joseph Marketing Corporation;**

NOW, THEREFORE, the BAC recommends the award of the contract for the **Procurement of Hybrid Corn Seeds Lot 2 – 1,035 bags Hybrid Yellow Corn Seeds (NSIC 2023 GMCN 89) (B30 Lot 2) under Corn Program–2025 GAA to St. Joseph Marketing Corporation**, subject to the approval of the Head of the Procuring Entity (HOPE) and compliance with post-award requirements as their bids were considered the Single Calculated and Responsive Bid;
