**BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE  
PROCUREMENT OF 291 HEADS GOAT (UPGRADED) (B37)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net), on March 8, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Procurement Of 291 Heads Goat (Upgraded) (B37)** under **Livestock Program-2025 GAA** with a total Approved Budget for the Contract (ABC) of **Nine Million Ninety-Eight Thousand Pesos (₱9,098,000.00)**;

WHEREAS, a pre-bid conference was conducted as scheduled on March 18, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually throu;

WHEREAS, the opening of bids was conducted as scheduled on April 2, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, two (2) bidders purchased bid documents and successfully submitted their bids. These were the **Tommy's Hogs and Cattle** and **Julimon International Agri Trading Corp.**;

WHEREAS, based on the preliminary deliberation, the **Tommy's Hogs and Cattle** has been found eligible and compliant with the requirements while the **Julimon International Agri Trading Corp.** has failed since the original copy of the bid documents was not signed;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 10, 2025 to determine the bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, **Tommy's Hogs and Cattle** is compliant with the evaluated class A documents and subject to post-qualification process to verify the eligibility, legal, technical, and financial requirements of the bid;

WHEREAS, after conducting the Post-Qualification Evaluation on April 16, 2025, the BAC determined that **Tommy's Hogs and Cattle** met all legal, technical, and financial requirements and are deemed as the Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, **RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract with a total amount of **₱8,206,200.00** to **Tommy's Hogs and Cattle**;

NOW, THEREFORE, the BAC recommends the award of the contract for the **Procurement Of 291 Heads Goat (Upgraded) (B37)** under **Livestock Program-2025 GAA** to **Tommy's Hogs and Cattle**, subject to the approval of the Head of the Procuring Entity (HOPE) and compliance with post-award requirements as their bids were considered the Lowest Calculated and Responsive Bid;


