WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for Procurement Of Drugs And Biologics (B40 Lot 1 and Lot 2) under Livestock Program with a total Approved Budget for the Contract (ABC) of One Million Five Hundred Thirty-One Thousand Three Hundred Pesos (P1,531,300.00) with procurement by lot as follows:

WHEREAS, a pre-bid conference was conducted as scheduled on March 18, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually https://tinyurl.com/Prebid-CodeB-03182025;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, only one bidder purchased bid documents and successfully submitted bid for lot 1 only, namely, P and J Agricultural Trading, Inc. There was no bidder for lot 2;

WHEREAS, upon opening of bid documents, the BAC members conducted an examination of the submitted technical and financial components to verify the completeness and compliance of the required documents. The bids were evaluated and rated as "PASSED";

WHEREAS, based on the preliminary deliberation, P and J Agricultural Trading, Inc has been found eligible and compliant with the requirements for lot 1;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 11, 2025 to determine the bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, P and J Agricultural Trading, Inc submitted the responsive bid and subjected to post-qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that P and J Agricultural Trading, Inc met all legal, technical, and financial requirements and deemed as the Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, RESOLVES AS IT IS HEREBY RESOLVED, to recommend the award of the contract with a total amount of \$\mathbb{P}721,310.00 to P and J Agricultural Trading, Inc;
