

## BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE PROCUREMENT OF VARIOUS ANIMAL FEEDS (B41- LOT 1)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net), on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Procurement Of Various Animal Feeds (B41)** under **Livestock Program** with a total Approved Budget for the Contract (ABC) of **Five Million Seven Hundred Forty-Eight Thousand Five Hundred Pesos (P5,748,500.00)** with procurement by lot as follows:

WHEREAS, a pre-bid conference was conducted as scheduled on March 18, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through <https://tinyurl.com/Prebid-CodeB-03182025>;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, three (3) bidders purchased bid documents and successfully submitted their bids. These were the **Hiron's General Merchandise**, **Happy Northmin, Inc.**, and **Pacifica Agrivet Supplies, Inc.**;

WHEREAS, based on the preliminary deliberation, only **Hiron's General Merchandise** has been found eligible and compliant with the requirements and rated as "PASSED" for lot 1 only. **Hiron's General Merchandise** did not bid for lot 2. On the other hand, the **Happy Northmin, Inc.** and **Pacifica Agrivet Supplies, Inc.** were declared as failed due to no "COMPLY" stated with each of the individual parameter of technical specifications;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 11, 2025 to determine the lowest calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, **Hiron's General Merchandise** submitted the responsive bid and subjected to post-qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **Hiron's General Merchandise** met all legal, technical, and financial requirements and deemed as the Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, RESOLVES AS IT IS HEREBY RESOLVED, to recommend the award of the contract with a total amount of **P5,334,509.60** to **Hiron's General Merchandise**;

NOW, THEREFORE, the BAC recommends the award of the contract for **Procurement Of Drugs And Biologics (B41 Lot 1)** under **Livestock Program** to **Hiron's General Merchandise**, subject to the approval of the Head of the Procuring Entity (HOPE) and compliance with post-award requirements as their bids were considered the Lone and Responsive Bid;
