**BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE
LABOR AND MATERIALS FOR THE CONSTRUCTION OF CHICKEN LAYING
HOUSE (B17-LOT 2)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Labor And Materials For The Construction Of Chicken Laying House (B17-Lot 2)** under **Livestock Program** with a total Approved Budget for the Contract (ABC) of **Nine Million Pesos (₱9,000,000.00)**;

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through <https://bit.ly/Prebid-CodeB-03172025>;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, four (4) bidders purchased bid documents and successfully submitted bids for lot 2. These were the **Fortgem Construction Supply, Zeart Construction Supply Inc., Regerys Construction and Supply**, and **BN Builders Construction and Supplies**;

WHEREAS, based on the preliminary deliberation, four bidders have been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 11, 2025 to determine the bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, **Regerys Construction and Supply** submitted the lowest calculated bid, however, was declared failed due to expression of Item 803 (3) Foundation Fill from 10.99 cu.m. to 10.99 lot;

WHEREAS, the BAC hereby resolves to conduct post qualification process to verify the eligibility, legal, technical, and financial requirements to the next lowest bidder, namely, **Fortgem Construction Supply**;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **Fortgem Construction Supply** met all legal, technical, and financial requirements and deemed as the Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, **RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract with a total amount of **₱8,891,349.14** to **Fortgem Construction Supply**;
