**BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE  
LABOR AND MATERIALS FOR THE CONSTRUCTION OF GOAT HOUSE**

**(B17-LOT 3)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net), on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Labor And Materials For The Construction Of Chicken Laying House (B17-Lot 3)** under **Livestock Program** with a total Approved Budget for the Contract (ABC) of **Three Million Six Hundred Thousand Pesos (P3,600,000.00)**;

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through <https://bit.ly/Prebid-CodeB-03172025>;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, only one (1) bidder purchased bid documents and successfully submitted bid for lot 3, namely, **AJP Builders and Supplies**;

WHEREAS, based on the preliminary deliberation, **AJP Builders and Supplies** has been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 11, 2025 to determine the bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, **AJP Builders and Supplies** submitted the single bid and subjected to post qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **AJP Builders and Supplies** met all legal, technical, and financial requirements and deemed as the Lone and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, **RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract with a total amount of **P3,553,585.37** to **AJP Builders and Supplies**;

NOW, THEREFORE, the BAC recommends the award of the contract for the **Labor And Materials For The Construction Of Chicken Laying House (B17-Lot 3)** under **Livestock Program** to **AJP Builders and Supplies**, subject to the approval of the Head of the Procuring Entity (HOPE) and compliance with post-award requirements as their bids were considered the Lone and Responsive Bid;
