BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE LABOR AND MATERIALS FOR THE CONSTRUCTION OF CHICKEN LAYING HOUSE (B17-LOT 4)

Resolution No. 072 was Series of 2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for Labor And Materials For The Construction Of Chicken Laying House (B17-Lot 4) under Livestock Program with a total Approved Budget for the Contract (ABC) of One Million Eight Hundred Thousand Pesos (\$\mathbb{P}1,800,000.00);

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through https://bit.ly/Prebid-CodeB-03172025;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, three (3) bidders purchased bid documents and successfully submitted their bids for lot 4. These were the Resaga Construction, Regerys Construction and Supply, and BN **Builders Construction and Supplies;**

WHEREAS, based on the preliminary deliberation, three bidders have been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 11, 2025 to determine the lowest calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, Resaga Construction submitted the lowest calculated bid;

WHEREAS, the BAC hereby resolves to declare Resaga Construction as the bidder with Lowest Calculated Bid and subject to post-qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that Resaga Construction met all legal, technical, and financial requirements and deemed as the Lowest and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, RESOLVES AS IT IS HEREBY RESOLVED, to recommend the award of the contract with a total amount of ₱1,534,725.00 to Resaga Construction;
