## BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE LABOR AND MATERIALS FOR THE CONSTRUCTION OF LEARNING CENTER (B3)

Resolution No. 073- 2025 Series of 2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for Labor And Materials For The Construction Of Learning Center (B3) under AMIA with a total Approved Budget for the Contract (ABC) of One Million Five Hundred Thousand Pesos (P1,500,000.00);

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through https://bit.ly/Prebid-CodeB-03172025;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, two (2) bidders purchased bid documents and successfully submitted their bid. These were the BN Builders and Construction Supplies and RTM Builders;

WHEREAS, based on the preliminary deliberation, the two bidders have been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 10 2025 to determine the lowest calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, BN Builders and Construction Supplies is the Lowest but failed for post qualification due to non-responsiveness to the data estimates based on plans, hence, evaluated the next lowest bidder which is the RTM Builders.

WHEREAS, based on the detailed evaluation, RTM Builders is eligible for post qualification and subjected to post-qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that RTM Builders met all legal, technical, and financial requirements and are deemed as the Single and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, RESOLVES AS IT IS HEREBY RESOLVED, to recommend the award of the contract with a total amount of \$\mathbb{P}\$1,499,500.00 to RTM Builders;
