

**BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE  
LABOR AND MATERIALS FOR THE CONSTRUCTION OF PESTICIDE  
ANALYTICAL LABORATORY (B4)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net), on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Labor And Materials For The Construction Of Pesticide Analytical Laboratory (B4)** under **Integrated Laboratory Division** with a total Approved Budget for the Contract (ABC) of **Eight Million Pesos (P8,000,000.00)**;

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through <https://bit.ly/Prebid-CodeB-03172025>;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, only one (1) bidder purchased bid documents and successfully submitted their bids, namely, **Quadcon Builders and Design**;

WHEREAS, upon opening of bid documents, the BAC members conducted an examination of the submitted technical and financial components to verify the completeness and compliance of the required documents;

WHEREAS, based on the preliminary deliberation, the bidder has been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 11, 2025 to determine the bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, BAC declared **Quadcon Builders and Design** as the lone bidder and subject to post-qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **Quadcon Builders and Design** met all legal, technical, and financial requirements deemed as the Lone and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, **RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract with a total amount of **P7,749,999.38** to **Quadcon Builders and Design**;


