

**BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE
LABOR AND MATERIALS FOR THE CONSTRUCTION OF MULTICROP DRYING
PAVEMENT (B6 LOT 3)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Labor And Materials For The Construction Of Multicrop Drying Pavement (B6 LOT 3)** under **Corn Program-2025 GAA** with a total Approved Budget for the Contract (ABC) of **Two Million Pesos (P2,000,000.00)**;

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through <https://bit.ly/Prebid-CodeB-03172025>;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, five (5) bidders purchased bid documents and successfully submitted their bids. These were the **ReGeRys Construction and Supply, Ilmar Construction and Supply, Allyde Construction and Supply, BN Builders and Construction and Supply, and Innovati Construction and Development Corporation**;

WHEREAS, based on the preliminary deliberation, the five bidders have been found eligible and compliant with the requirements;

WHEREAS, based on the detailed evaluation on April 10, 2025, **Ilmar Construction and Supply** submitted the lowest calculated bid for B6 Lot 3;

WHEREAS, the BAC declared **Ilmar Construction and Supply** as the bidder with Lowest Calculated Bid and subject to post-qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **Ilmar Construction and Supply** met all legal, technical, and financial requirements and deemed as the Lowest Calculated and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, **RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract with a total amount of **P 1,705,161.41** to **Ilmar Construction and Supply**;

NOW, THEREFORE, the BAC recommends the award of the contract for the **Labor And Materials For The Construction Of Multicrop Drying Pavement (B6 LOT 3)** under **Corn Program–2025 GAA to Ilmar Construction and Supply**, subject to the approval of the Head of the Procuring Entity (HOPE) and compliance with post-award requirements as their bids were considered the Lowest Calculated and Responsive Bid;
