**BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE  
LABOR AND MATERIALS FOR THE CONSTRUCTION OF MULTICROP DRYING  
PAVEMENT (B6 LOT 4)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net), on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Labor And Materials For The Construction Of Multicrop Drying Pavement (B6 LOT 4)** under **Corn Program-2025 GAA** with a total Approved Budget for the Contract (ABC) of **Two Million Pesos (P2,000,000.00)**;

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through <https://bit.ly/Prebid-CodeB-03172025>;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, only one (1) bidder purchased bid documents and successfully submitted bid, namely, **BN Builders Construction and Supply**;

WHEREAS, based on the preliminary deliberation, **BN Builders Construction and Supply** has been found eligible and compliant with the requirements;

WHEREAS, based on the detailed evaluation on April 10, 2025, **BN Builders Construction and Supply** submitted the single bid for B6 Lot 4;

WHEREAS, the BAC declared **BN Builders Construction and Supply** as the bidder with Single Bid and subject to post-qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **BN Builders Construction and Supply** met all legal, technical, and financial requirements and deemed as the Single and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, **RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract with a total amount of **P1,996,209.41** to **BN Builders Construction and Supply**;
