BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE LABOR AND MATERIALS FOR THE ESTABLISHMENT OF SOLAR-POWERED IRRIGATION SYSTEM (SPIS) AT BRGY. TIGABONG CANTILAN, SURIGAO DEL SUR (B11)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for Labor And Materials For The Establishment Of Solar-Powered Irrigation System (SPIS) At Brgy. Tigabong Cantilan, Surigao Del Sur (B11) under High Value Crops Development Program with a total Approved Budget for the Contract (ABC) of One Million Six Hundred Thousand Pesos (P1,600,000.00);

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through https://bit.ly/Prebid-CodeB-03172025;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, three (3) bidders purchased bid documents and successfully submitted their bids. These were the MCLA Construction, AJP Builders, and DDS Builders;

WHEREAS, based on the preliminary deliberation, the three bidders have been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 10, 2025 to determine the lowest calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, **DDS Builders** submitted the lowest calculated bid and subjected for post qualification;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **DDS Builders** met all legal, technical, and financial requirements and deemed as the Lowest Calculated and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, RESOLVES AS IT IS HEREBY RESOLVED, to recommend the award of the contract with a total amount of P1,432,500.74 to DDS Builders;
