LABOR AND MATERIALS FOR THE ESTABLISHMENT OF SOLAR-POWERED
IRRIGATION SYSTEM (SPIS) AT BRGY. NUEVO TRABAJO, SAN LUIS, AGUSAN
DEL SUR (B13)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Labor And Materials For The Establishment Of Solar-Powered Irrigation System (SPIS) At Brgy. Nuevo Trabajo, San Luis, Agusan Del Sur (B13)** under **High Value Crops Development Program** with a total Approved Budget for the Contract (ABC) of **One Million Six Hundred Thousand Pesos (₱1,600,000.00)**;

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through <https://bit.ly/Prebid-CodeB-03172025>;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, only one (1) bidder purchased bid documents and successfully submitted their bid, namely, **DDS Builders**;

WHEREAS, upon opening of bid documents, the BAC members conducted an examination of the submitted technical and financial components to verify the completeness and compliance of the required documents. The bids were evaluated and rated as "PASSED";

WHEREAS, based on the preliminary deliberation, **DDS Builders** has been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 10, 2025 to determine the single bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, **DDS Builders** submitted a single bid;

WHEREAS, the BAC hereby resolves to declare **DDS Builders** as the bidder with Single Bid and subject to post-qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **DDS Builders** met all legal, technical, and financial requirements and deemed as the Single Calculated and Responsive Bidder;

Whereas, the BAC, after careful deliberation and verification of submitted documents, **RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract with a total amount of **₱1,402,266.10** to **DDS Builders**;




