**BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE  
LABOR AND MATERIALS FOR THE CONSTRUCTION OF GOAT HOUSE  
(B16-LOT 1)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net), on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Labor And Materials For The Construction Of Goat House (B16-Lot 1)** under **Livestock Program** with a total Approved Budget for the Contract (ABC) of **Fourteen Pesos (P14,000,000.00)**;

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through <https://bit.ly/Prebid-CodeB-03172025>;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, two (2) bidders purchased bid documents and successfully submitted their bids for lot 1. These were the **Quadcon Builders and Design** and **Ilmar Construction**;

WHEREAS, based on the preliminary deliberation, the two bidders have been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 11, 2025 to determine the single bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, **Ilmar Construction** submitted the lowest bid and subjected for post-qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **Ilmar Construction** met all legal, technical, and financial requirements and deemed as the Lowest and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents,  
**RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract with a total amount of **P1,782,346.99** to **Ilmar Construction**;
