BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE LABOR AND MATERIALS FOR THE CONSTRUCTION OF ORGANIC FOOD PROCESSING FACILITY (B2)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for Labor And Materials For The Construction Of Organic Food Processing Facility (B2) under Organic Agriculture Program 2025 GAA with a total Approved Budget for the Contract (ABC) of Five Million Pesos (₱5,000,000.00);

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through https://bit.ly/Prebid-CodeB-03172025:

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the the DA 13 Conference Hall, Butuan City;

WHEREAS, only one (1) bidder purchased bid documents and successfully submitted their bid, namely, RTM Builders;

WHEREAS, based on the preliminary deliberation, the **RTM Builders** has been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 10 2025 to determine the lowest calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, **RTM Builders** is the Lone Bid and subject to post-qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **RTM Builders** met all legal, technical, and financial requirements and are deemed as the Single and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, RESOLVES AS IT IS HEREBY RESOLVED, to recommend the award of the contract with a total amount of \$\mathbb{P}4,999,496p.55 to RTM Builders;
