

**BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE
 PROCUREMENT OF 29,000 PCS ASEXUALLY PROPAGATED DURIAN PLANTING
 MATERIALS (B32)**

**Resolution No. 092-2025
 Series of 2025**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on March 8, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Procurement of 29,000 pcs Asexually Propagated Durian Planting Materials (B32)** under **High Value Crops Development Program-2025 GAA** with a total Approved Budget for the Contract (ABC) of **Two Million Six Hundred Ten Thousand Pesos (₱2,610,000.00)**;

WHEREAS, a pre-bid conference was conducted as scheduled on March 18, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through <https://tinyurl.com/Prebid-CodeB-03182025>;

WHEREAS, the opening of bids was conducted as scheduled on April 2, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, two (2) bidders purchased bid documents and successfully submitted their bids. These were the **Paman Plant Nursery and the Pelf Plant Nursery**;

WHEREAS, based on the preliminary deliberation, the 2 bidders have been found eligible and compliant with the requirements;

WHEREAS, the opening of bids was conducted as scheduled on April 2, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, upon opening of bid documents, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 10, 2025 to determine the lowest calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, the results of the detailed bid evaluation are as follows:

Bidders	Bid Offer
Paman Plant Nursery	2,610,000.00
Pelf Plant Nursery	1,450,000.00

WHEREAS, based on the detailed evaluation:

- **Pelf Plant Nursery** is the lowest bidder and is compliant with the evaluated class ‘A’ documents. No submission of the Other Relevant Documents (1st Quarter Tax Payment and Certificates of Stocks Availability);
- **Paman Plant Nursery** is the 2nd lowest bidder and is compliant with the evaluated class ‘A’ documents.

WHEREAS, the BAC hereby resolves to declare **Pelf Plant Nursery** as the bidder with Lowest Calculated Bid and subject to post-qualification process to verify the eligibility, legal, technical, and financial requirements of the lone and lowest calculated bids;

WHEREAS, during the Post-Qualification Evaluation on April 15, 2025, documentary requirements were verified, however, it was found out that **Pelf Plant Nursery** has an insufficient number of durian seedlings in stock. Based on the actual evaluation, the available seedlings at their nursery account for only approximately 10% (or around 3,000 certified and tagged seedlings only) of the total requirement of 29,000 (100%) as stated in the procurement. Given this significant deficiency in available stock, **Pelf Plant Nursery** is hereby considered **non-responsive bidder** in accordance with the procurement guidelines. Therefore, it is hereby resolved to conduct post qualification evaluation to the next lowest calculated bidder which is the **Paman Plant Nursery** in accordance with the provisions of the procurement process.

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **Paman Plant Nursery** met all legal, technical, and financial requirements and deemed as the Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, IT IS HEREBY RESOLVED, to recommend the award of the contract with a total amount of **₱2,610,000.00** to **Paman Plant Nursery**;

NOW, THEREFORE, the BAC recommends the award of the contract for **Procurement of 29,000 pcs Asexually Propagated Durian Planting Materials (B32)** under **High Value Crops Development Program-2025 GAA** to **Paman Plant Nursery**, subject to the approval of the Head of the Procuring Entity (HOPE), Arlan M. Mangelen, to award the **Procurement of 29,000 pcs Asexually Propagated Durian Planting Materials (B32)** to **Paman Plant Nursery** as its bid was considered the Lowest Calculated and Responsive Bid;
